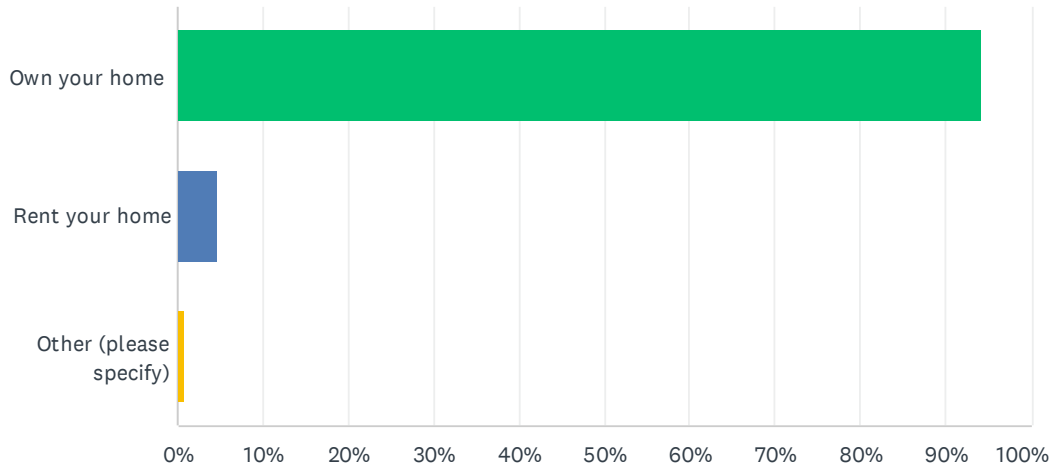

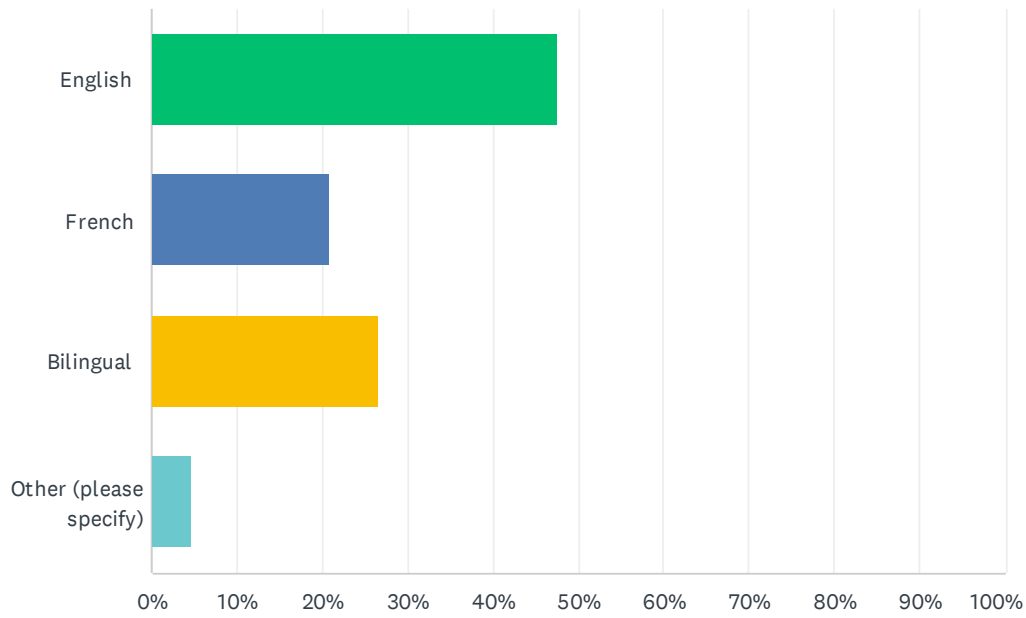

Q5 What is your language spoken at home?

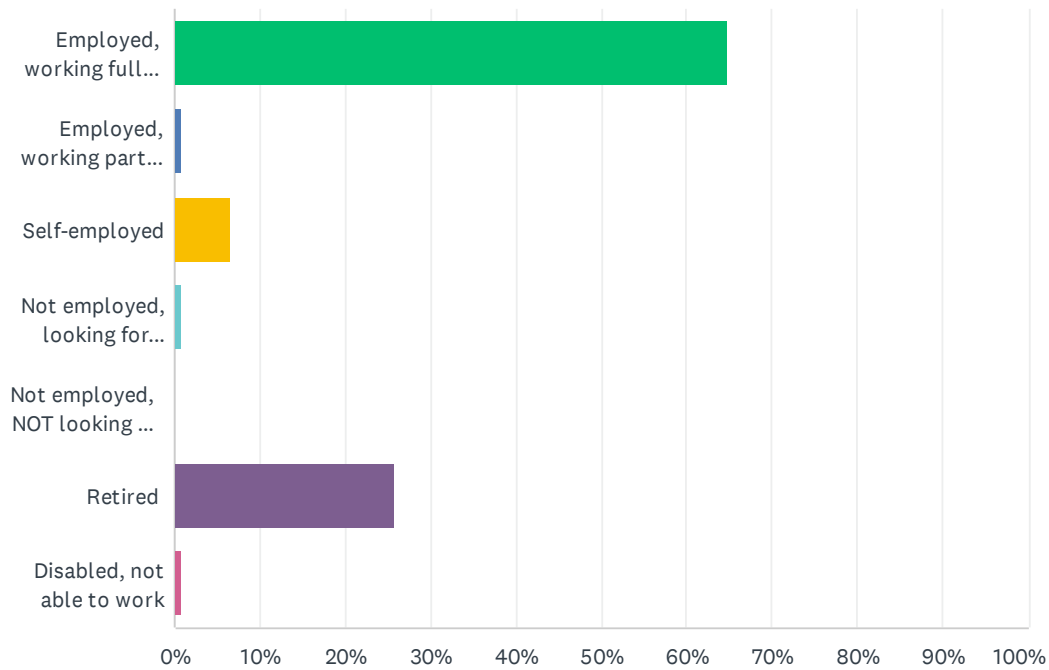

Q6 Which of the following best describes your employment status?

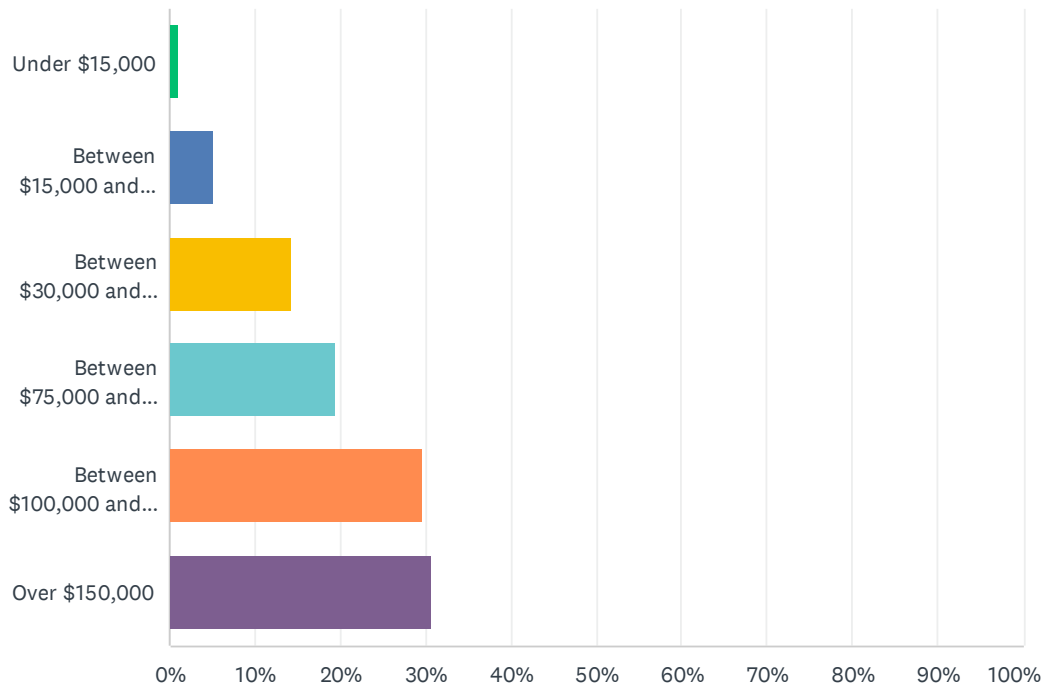

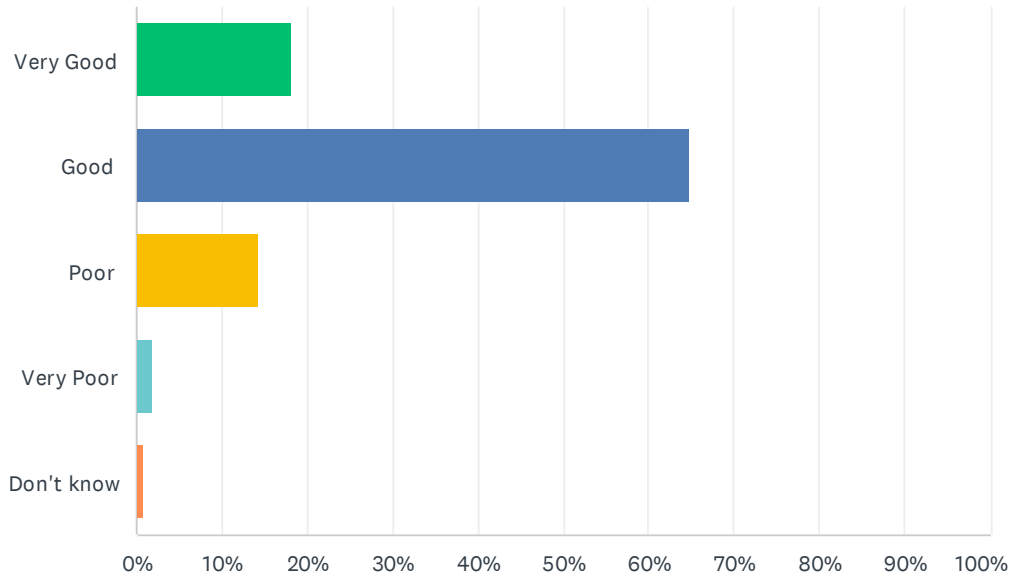

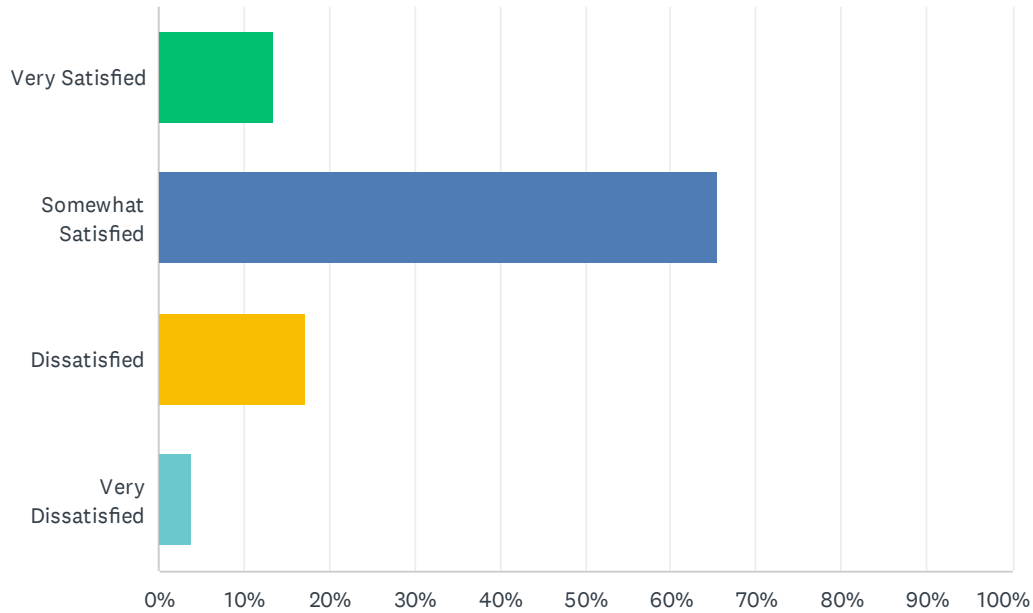

Q14 Considering all the programs and services the Municipality of Casselman provides, please rate your overall satisfaction?

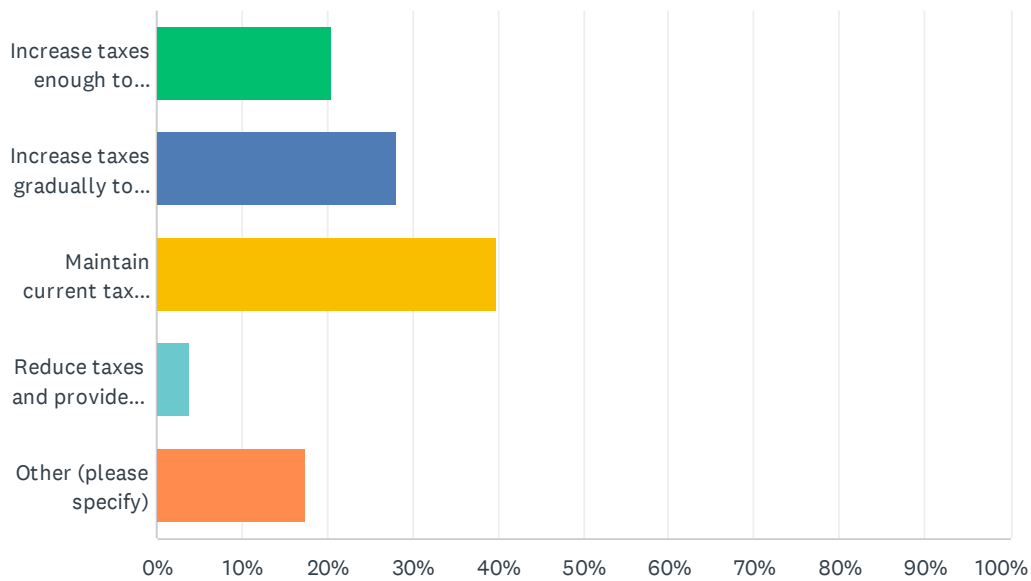

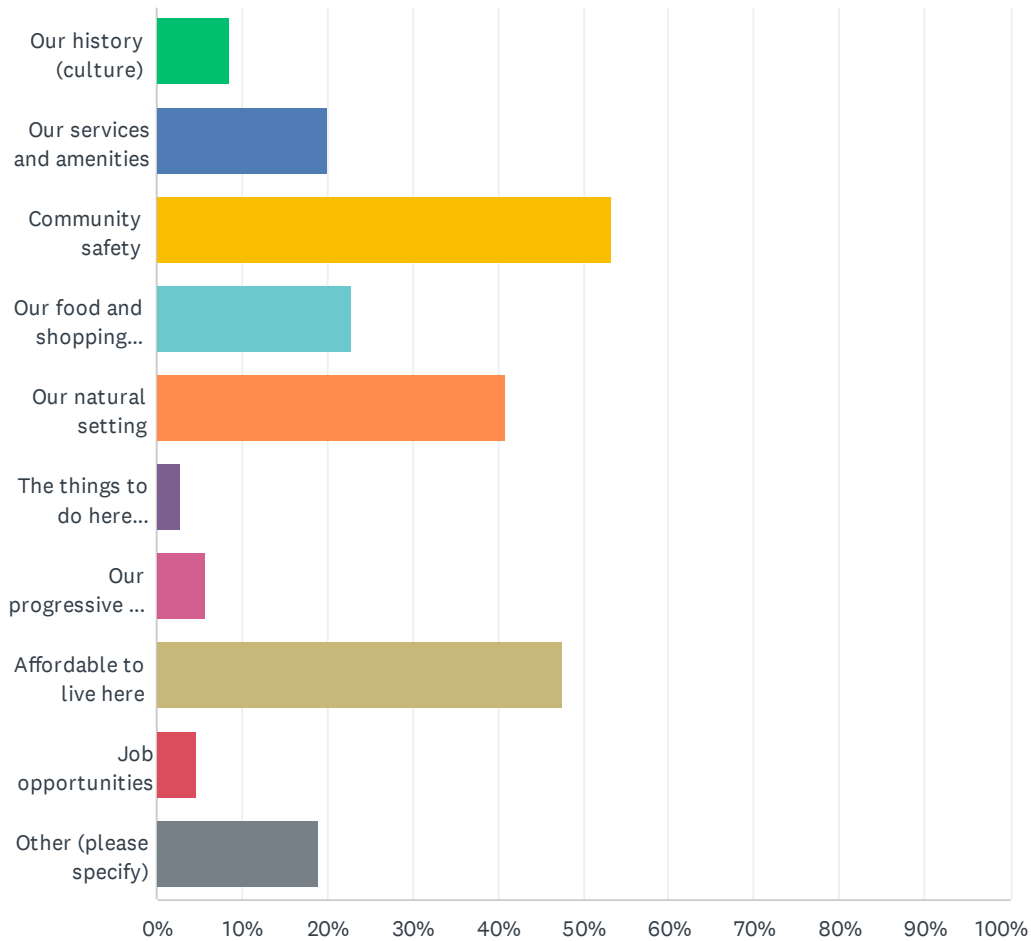

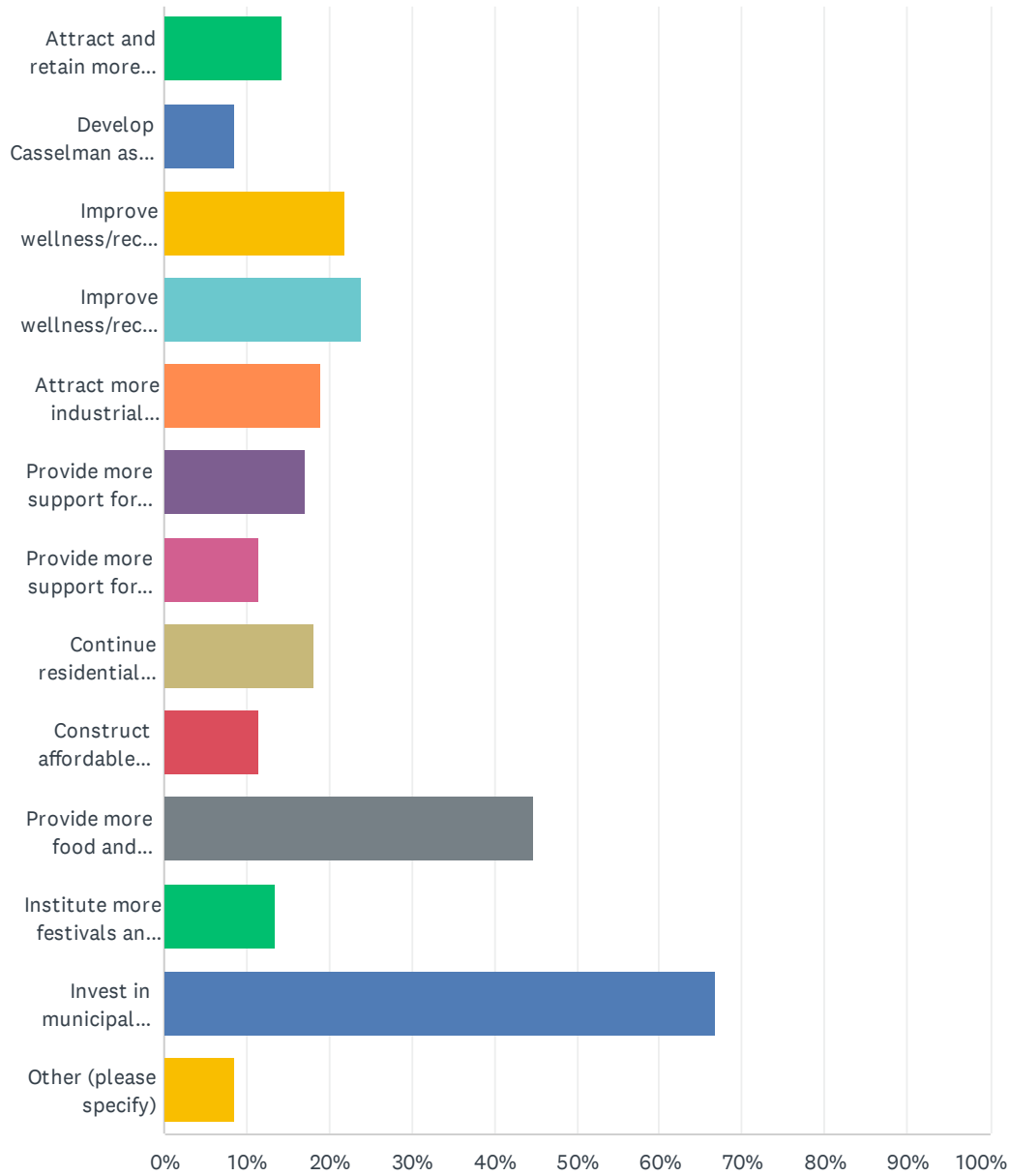

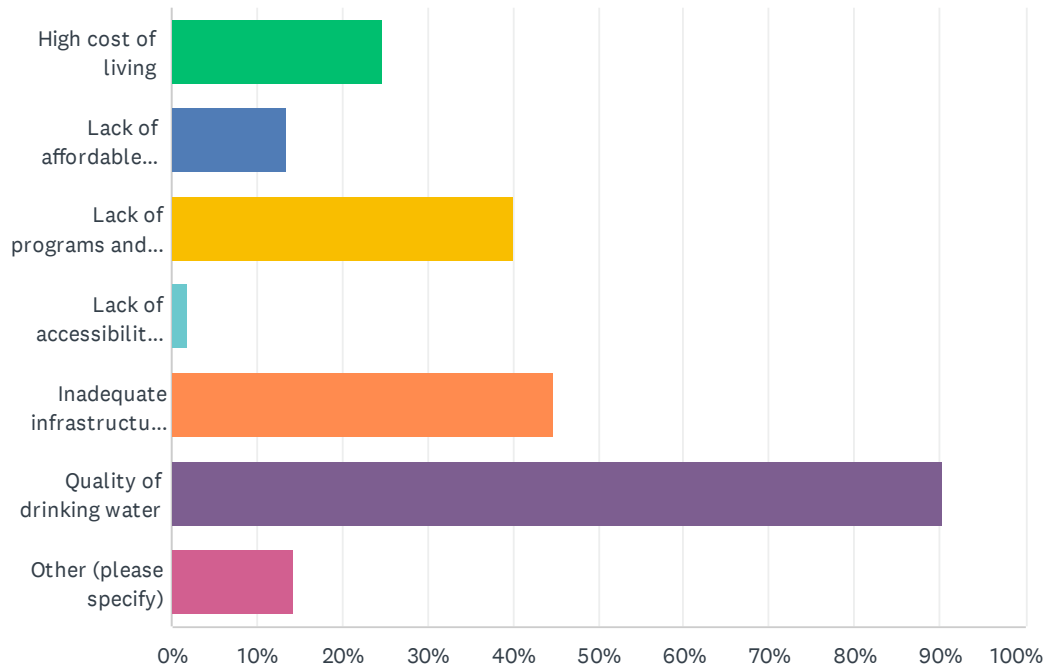
